

TRANSFER OF OWNERSHIP DIRECTIONS & FORM

1. Write in the name and full mailing address of the buyer.
2. Fill in the name and registration number of the animal to be transferred.
3. Write in the date of purchase - the date on which the animal was actually bought.
4. The seller must personally sign his name in the space for that purpose, and give his complete address.
5. If the animal to be transferred is a mare and has not been served, the words "Not Served" must be written in the space for service.
6. Transfer papers having erasures - names, dates or signatures scratched out and rewritten - are not acceptable. If a mistake is made use a fresh blank.
7. All writing must be in ink. Do not use lead pencil.
8. Send correct money to meet fees when sending transfer requests.
9. No name changes for mares after they have a foal registered to them.
10. No name changes for stallions after they have a foal registered to them.

You will receive the same certificate of registration back, your name will be inserted into the first available position. You do not receive a new set of papers, unless you pay an **additional new certificate fee**, in addition to the member or non-member transfer fees.
